#### **COURSE DESCRIPTION**

Qualitative research methodology combines scientific logical inference with an interpretive, reflexive process to understand the deep structures of the world around us. This course offers a survey of the various ways of knowing and deconstructing those deep structures, including a treatment of methodological epistemologies, with an emphasis on observational and ethnographic interviewing methods. Our goal is to consider every element of the qualitative research process from design to analysis, focusing on your individual projects and next career steps.

#### **COURSE REQUIREMENTS**

Research Memos. The research memo is intended to socialize you into writing and thinking about the research process each week. Use the research memo as a space to respond to the course readings and discussions, talk about your own research concerns, or to submit a set of participant observation notes or other research product for me to review. I will read and respond to your memos each week. Memos are due at the beginning of class in weeks II through XI for a total of **ten** (10) research memos.

Research Blog. Making your research accessible to the public is both essential to your career and your responsibility as a scholar. For this course, you will develop a research blog on whatever platform(s) best suit(s) your work (Tumblr, WordPress, Blogspot, Flickr, Instagram). This blog should translate your esoteric and/or largely boring research into something glorious for mass public consumption. This blog should be so awesome that your parent or guardian actively learns what an RSS feed is and subscribes to your blog's RSS feed. You can reflect on the research process, write about new developments vis-à-vis your research area, review key books or articles, etc. You are to launch this blog by Week III and provide me with the url. I will check your blog throughout the semester and make suggestions as necessary, but I fully expect you to curate your blog and provide suggestions on each other's blogs. Updates should be made each week. For inspiration (and a great deal of consternation), see Philip Cohen's Family Inequality blog and Joe Feagin's Racism Review. Although not necessary for this course, see Celeste Watkins-Hayes' and space scientist Jim Wild's websites for ideas about how to integrate your personal brand with your academic research brand.

<u>Final Paper</u>. Methodology articles are perhaps the least understood, most loathed, but also the most widely cited articles in sociology. Thus, for your final paper, you will write a methodology article. Ideally, this article will be an elaborated version of the methods section of your thesis or whatever project you are working on in this class. The methodology article considers the research process as well as the ethical, epistemological, and theoretical concerns tied to the deployment of that method. For inspiration, become friends with key qualitative research methods journals (*Qualitative Research*, *Ethnography*, *Journal of Contemporary Ethnography*, *Journal of Ethnographic and Qualitative Research*) and locate key methodology articles in generalist journals in sociology and other social science fields.
